## By-Laws Applicable for the Beef Section

- 57 All cattle must be entered in the name of the bona-fide owner.
- 58 The date of birth of all breeding cattle must be stated at the time of entry. All beef cows three years and over must be shown with own calf at foot, born on or after 1st June in the current Show Season. All purebred cattle shall be led into the Show Ring when required by the stewards or judges.
- 59 The age of cattle shall be computed as at 1st June.  
**NB:** As the age of all cattle is determined from the 1st June in each year, all animals shall be deemed to be one year older on this date.
- 60 Cows and heifers calving after entry has been made, may be transferred to the classes for which they have become eligible.
- 61 In all applicable classes of female stock, Judges to withhold awards for cattle which in their opinion, are barren.
- 62 All bulls twelve months old and over, must be rung and be led by the ring and be under adequate supervision when being shown. All bulls two years and over must have two leaders. Bulls stalled in the Pavilion must be securely tied in the stalls with a good strong halter and rope as well as a strong neck chain.
- 63 In the case of all beef females, yearlings and over, may be led with a nose clip (not ring) at all Shows.
- 64 All pedigree cattle one year old and over must be registered with a recognised breed society and no bull or heifer under two years of age shall be eligible for senior championships.
- 65 Manawatu & West Coast A & P Assn reserves the right to amalgamate classes where there are insufficient entries.
- 66 A Valid R.A.S. Highland Passport **must** accompany all Highland Cattle entries. Entries received without a Passport will **not** be accepted.

## **Information for Exhibitors Rules and Regulations**

The rules and Regulations as issued by the Royal Agricultural Society of New Zealand (Inc) for the governance and conduct of A & P Shows have been adopted by the Manawatu & West Coast A & P Association. It is the responsibility of exhibitors to be conversant with these rules. Copies of the Rules and Regulations are available on request.

### **General**

- a) All exhibits must be shown up to their respective ages and no two year old may be shown as a three year old and no yearling may be shown in a two or three year old class.
- b) Exhibitors are requested not to tether stock in Judging Rings.
- c) All cattle entered in the purebred classes must be entered, if one year old or over, in a Herd Book of the breed. If under one year of age, they must be eligible for entry. The names and pedigree of all such cattle must be stated on the Entry Form and if the exhibitor is not the breeder, the breeder's name must also be stated.
- d) No stock shall be brought to the Showground's earlier than 1 day prior the Show unless permission is given from the Chief Steward.

### **TB Testing**

All cattle including yearlings entered for this Show must be from a TB free and accredited Herd within the preceding 12 months. Cattle from a TB and accredited herd within a declared Movement Control Area must be tested and passed within 60 days of movement.

#### **A copy of the Test Certificate must accompany all entry forms.**

Checks will be made for TB declaration cards on stock arrival.

All animals must comply with current Animal Health Board regulations.

**INSPECTION:** The Committee reserves the right to inspect at random any cattle for tattoos or identification to establish TB Status.

**NAIT:** For cattle being moved from 1 July 2012: A NAIT approved RFID tag is mandatory for all movements of cattle, including day old calves. NAIT approved RFID cattle tags are white only. Please do not remove tags if cattle are identified with Animal Health Board or MINDA tags. As of 1 July 2012 a secondary tag is no longer required under the new NAIT scheme. All animals being exhibited at the Show come under the standard identification and ASD regulations. These cattle will require the NAIT approved RFID tag. It is the livestock exhibitors responsibility to record all animal movements with NAIT 48 hours prior to leaving the farm/property for the Show and then within 48 hours of returning to the farm/property from the Show.

1. Animals are from a clear status herd
2. Routine TB testing requirements are complete.  
(To arrange a TB test please contact TBfree on 0800 482 4636)
3. Animals are from a Movement Control Area.
4. If yes to 3, pre movement will be completed within 60 days of movement to show.
5. All animals presented for showing will be compliant with NAIT requirements  
(This will include recording of NAIT movement & identification with approved RFID ear tag.)

## Auxiliary Equipment Not Permitted

In the interest of safety and tidiness in the Pavilion, Exhibitors will not be permitted to bring any items of electrical equipment into the Pavilion. This includes auxiliary milking plant, water heating equipment, cooking appliances etc. Blow driers are allowed.

## Stalling Of Entries

In the event of catalogued entries not being exhibited at the Show, the Chief Steward shall have the right to re-allocate such stall spaces.

**Note** - IT IS A REQUIREMENT OF ALL EXHIBITORS TO KEEP THEIR AREA CLEAN AND TIDY THROUGHOUT THE DURATION OF THE SHOW.

**NO STRAW** is to be brought onto the grounds. Woodchip bedding will be available for all animals. Feed receptacles will not be provided in the Cattle Pavilion. Exhibitors wishing to feed meal or dry stock feed should bring suitable containers with them. Water troughs are located in convenient positions in the Pavilion.

## Limitation on Entries

Shows in recent years have attracted progressively increased livestock entries and while it will probably not be necessary, the Committee reserves the right to limit entries. Exhibitors are directed to the conditions and by-laws set out in each Schedule. If any entry has to be refused, entry fees will be refunded in full.

This section is run under the rules & regulations of the RAS. The rules of the Dexter Cattle Society of NZ Inc for purebred & grade registered animals apply. Only PUREBRED cattle are eligible for NI Supreme Award. Dexters may be shown clipped or unclipped.

Class 5209 **COW 3 YEARS & OVER**, with her own calf/calves at foot; both to be paraded. Calf must be born on or after 1<sup>st</sup> June 2014.

Class 5210 **COW 2 YEARS**, with or without her own calf/calves at foot. Calf must be born on or after 1<sup>st</sup> June 2014.

Class 5211 **YEARLING HEIFER**, born on or after 1<sup>st</sup> June 2013.

Class 5212 **HEIFER CALF**, born on or after 1<sup>st</sup> June 2014.

Class 5218 **OPEN HANDLER** – over 17 yrs. To be judged on showmanship. Any age/grade Dexter.

Female, any age

**GROUP CLASSES**

CLASS 5220 **BEST UDDERED COW**, 2 yrs & over, purebred or grade.

CLASS 5221 **PAIR OF CALVES** – either sex, born since 1<sup>st</sup> June 2014, owned by the one exhibitor.

CLASS 5222 **GROUP OF 3 PUREBRED ANIMALS**, by same sire or dam – any age, not necessarily owned by one exhibitor.

CLASS 5223 **1 BULL & 2 FEMALES** – any age, owned by the one exhibitor
