JUDGING & PENNING ARRANGEMENTS

All sheep will be judged from 9.00am on Saturday 8th November.

Sheep must be penned by 8.30am sharp, ready for judging.

Departure time – **Not Before** 4.00pm Saturday 8th November.

Portable loading ramps will be available to assist with loading and unloading. Sheep **must not** be removed from the Pavilion until after **4.00pm on Saturday**. These conditions will not be varied except in exceptional circumstances approved by the Chief Steward. When making transport arrangements, Exhibitors should take this into consideration as dispensation will not be given to suit particular transport arrangements.

GENERAL INFORMATION

- 1 All entries and general conduct of the Show are subject to the By-Laws and Regulations as published.
- 2 Sheep entered in classes in pens of two or more cannot be entered in single entry classes, except where especially stated.
- 3 All entries in Purebred classes to be shown in full wool unless otherwise stated.
- 4 Exhibitors are reminded that the use of Bloom Dip or any artificial colouring is now covered by Government Regulation.

RULES & REGULATIONS

The rules and Regulations as issued by the Royal Agricultural Society of New Zealand (Inc) for the governance and conduct of A & P Shows have been adopted by the Manawatu & West Coast A & P Association. It is the responsibility of exhibitors to be conversant with these rules. Copies of the Rules and Regulations are available on request.

Limitation on Entries

The Committee reserves the right to limit entries. Exhibitors are directed to the conditions and by-laws set out in each Schedule. If any entry has to be refused, entry fees will be refunded in full.

Drinking Utensils

Drinking utensils will not be supplied for stock in the Sheep Section and exhibitors should bring suitable containers to the show. Exhibitors are also reminded that only town-supply water is available.

Shearing Conditions

No ram shown in wool shall have been shorn later than **1st March 2014**.
No ewe shown in wool shall have been shorn later than **1st January 2014**,
except ewe hoggets which shall have been shorn no later than
30th January 2014.

BY-LAWS APPLICABLE FOR THE SHEEP SECTION

Protests and Objections

- 30 The determination of a judge shall be final as between all competitors, unless an objection is made to any exhibit and allowed on the ground of disqualification.
- 31 Every objection or protest must be made in writing within one hour of the judging of the class in question, signed by the person making such complaint, and delivered to the Secretary. The Objector shall, at the time of making such objection, lodge the sum of \$40 dollars which shall be forfeited to the Association should the objection be considered frivolous or vexatious.
- 32 Notwithstanding anything contained in the above rule, the Controlling Body may cause an investigation to be made or demand an explanation concerning any matter, which in their opinion, is considered necessary, and may so enforce penalties, fines and forfeiture's as is deemed expedient.
- 33 Protests and complaints against any exhibit must be made in writing. If lodged before judging is commenced, the onus of disproof will rest upon the person protesting. The Committee shall have power to refuse to entertain any protest or complaint lodged not later than the last day of the Show.
- 34 All protests, objections, and every matter in dispute, of whatever nature, by or between any person whatsoever, shall be determined by the Judicial Committee whose decision shall be absolutely final and binding on all parties, whether such dispute be between any person or persons and the Association.
- 35 The Chairperson of schedule committees or chief stewards shall have, at their discretion, power to decide any dispute in their respective divisions after consultation with the stewards of the section involved.

Prizes

- 36 All prize awards will be paid within two months of the Show.
- 37 The Association reserves the right to substitute trophies in lieu of cash prizes or vice versa at their discretion, and any dispute in connection with private prizes shall be settled by the Committee, whose decision shall be final.

- 38 In awarding championships, the Judges will select another animal to be called the "Reserve", to supplant the Champion in case of disqualification.
- 39 Reserve Champion to be selected from first and second prizes in respective divisions, and a certificate issued to the Reserve Champion.
- 40 Championships will only be awarded as provided where there are at least three exhibitors, unless, in the opinion of the Judge, an animal is deemed worthy of the award.
- 41 If a prize winner be afterwards disqualified, the Committee may, with or without the advice of the Judge, decide whether the next animal on the list shall gain the prize.
- 42 The Association shall not be responsible or liable in case of any error, misstatement, or misdescription appearing in any Prize Schedule or Show Catalogue, or in any Form or Certificate of Entry, or in any advertisement or notification, whether posted, displayed or published. It will however, be the duty of the Association or the Secretary and other members of its office staff, to take all proper care to avoid any such error, misdescription or misstatement. Names of judges and stewards, (if any) shown in the Schedule or in the Show Catalogue are intended to be informative only, and are subject to such changes from time to time as the Association may in its discretion make, and no exception shall be taken by any judge or exhibitor by reason of any change.
- 43 All trophies will be presented at the discretion of the Committee. All trophies will become perpetual trophies as from the 1991 Show.
- 44 The Committee reserves the right to make any alteration in Show timetable, or to postpone the Show, or withdraw any event as may be deemed desirable.

By-Laws

- 67 All sheep must be entered in the name of a bona-fide owner, and other than those in commercial classes must be from registered flocks. Where the exhibitor is not the breeder, the name of the breeder must be stated on the entry form. Sheep shall be identified in accordance with the rules and regulations of the particular Breed Society with which the sheep are registered.
- 68 The giving of a prize to a sheep shall imply that the judges are satisfied that such sheep are fairly shorn and fairly presented.

- 69 **Definition of hogget:** A sheep born after **1st July** in any one year shall be considered a hogget up to and including **31st December** in the following year except in the case of the Dorset Horn and Poll Dorset sheep when **May 1st** should be substituted for **July 1st**.
- 70 Hoggets are eligible for championship judging unless otherwise stated.
- 71 Dry mixed age ewes will not be eligible to compete for championship.
- 72 All sheep in shorn classes must be machine shorn on or after **20th July** in the current year and no later than **28 days** before the date of the Show.
- 73 In purebred classes for a ewe and her suckling lamb, the lamb must be of the same breed as the ewe.
- 74 Championships will only be awarded where, in the opinion of the Judge, an animal is deemed worthy of the award, but medals may only be given where there are three or more exhibitors. In such cases, certificates will be issued.
- 75 No stud sheep or lambs, rams or rigs admitted in prime stock classes.
- 76 Breeding to be stated on entry forms in prime stock classes.
- 77 If Ryeland long-Wool bred, sheep or lambs must be entered in long wool classes.

HEALTH & SAFETY IN EMPLOYMENT ACT 1992

It is important to bring to your attention the Health & Safety in Employment Act 1992. The Act sets out to attempt to remove hazards that could cause death or serious harm. The Act has requirements not only toward employees but also the public. 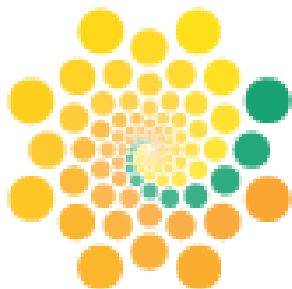
