1. Event is run under NZPCA Rules.
2. Approved helmets to be worn when mounted at all times.
3. Pony Club uniform or tidy attire for competitors – no plaiting or riding jackets.
4. Riders may enter and compete in ONLY ONE of the four jumping height classes.
5. Riders on lead rein may only enter Obstacle/Poles on the ground jumping event.
6. Committee reserves the right to alter classes.
7. NO refunds will be made unless the event is cancelled or the Judicial Committee considers there are valid reasons for doing so.
8. Riders must be aged 12 years or under at the date of the competition.
9. No whips or spurs permitted in games events.
10. Lead rein must NOT be attached to pony's bit.
11. Lead rein events are for children who do not normally ride off the lead at rallies/shows.
12. Class sizes may be capped, with postal entries taking priority.
13. Postal entries close on Wednesday 08 October 2014.
14. Entries will be accepted by email provided the entry fee is received by Wednesday 08 October (no payment on the day accepted for postal entries).
15. All protests should be directed to the Show Secretary and will be heard and decided by the event's Judicial Committee.
16. Competitors are asked to remove dung from the horse float parking area before leaving.
