Terms and Conditions

- 1. All bookings will only be accepted with a 10% deposit of the total value of the booking. Once the site has been confirmed, you must pay the balance as invoiced to secure your trade space or sponsorship.
- 2. Payment is to be made BEFORE 5 DECEMBER 2014 by direct credit to NZEF NEC, 02-0428-0287292-25 with your business name and online entry reference (from online booking).
- 3. Power connections are extra and must be ordered with the online booking. Site Holders to supply own overhead cover and 30m extension cord.

- 4. Sub-letting is not permitted without written authority from the Show Organising Committee and a fee may be imposed if your request is granted.
- 5. The committee reserves the right to accept or decline any booking and does not need to give any reason for doing so.
- 6. Exhibitors are expected to have their sites fully operational during the full advertised opening hours of the Show.
- 7. The Distribution of any form of promotional material or other forms of marketing outside of the Exhibitors site boundary is prohibited unless arranged with the Show Organising Committee.
- 8. The use of amplifiers or loud speakers by Exhibitors is restricted to the extent that it does not affect other exhibitors or competitors.
- 9. The Show Organising Committee will not be liable for loss or damage to the Exhibitors property while it is on the Show Site.
- 10. Exhibitors must comply with the Health & Safety Employment Amendment Act 1992 and subsequent amendments, and must comply with its provisions. All Tent and Marquee pegs, spikes or protruding objects must be covered.
- 11. The Show Organising Committee shall not be liable to the Exhibitor for any compensation whatsoever as a result of the cancellation or postponement of the Show. Any refund to Exhibitors as a result of cancellation or postponement will be at the discretion of the Show Organising Committee.
- 12. Exhibitor cancellations must be made in writing Fax and Email will be accepted. If on or after Friday 7th December 2014, the Show Organising Committee shall retain all monies received. If Prior to Friday 7th December, 2014, any refund shall be at the Show Organising Committee's discretion, not withstanding that a portion shall be retained to cover any expenses or costs.
- 13. The Show Organising Committee has the right to cancel this contract and to retain any monies paid in relation to this contract if the Exhibitor infringes any of the exhibiting conditions.
- 14. It is your responsibility to leave your trade site in the condition it was when you setup. Please remove any rubbish from your sites.

FOOD VENDORS

- 1. Food outlets will be sited together in the designated Food Court areas, with the decision on placement being the responsibility of the Show Organising Committee.
- 2. Full payment at time of confirmation with a copy of your Food Licence is required.
- 3. Each Food Trader /handler requires its own Environmental Health Licence. You are required to contact Taupo District Council at least 4 weeks before our event to apply for any trading permits and licences. Food Traders will incur a charge to receive the permit.
