1. Entries will ONLY be accepted on the **Official HOY Entry Form & Eventing Section Entry Form**, both to be completed and sent to HOY, as above.
2. The organizing committee reserves its rights, as laid out in the wording of ESNZ Articles 629 & 610.
3. These classes will be run under FEI Rules and Regulations updated August 2013.
4. The Organising Committee reserves the right to ballot entries if necessary as laid out in the wording of ESNZ Article 628.2
5. All horses are required to have either FEI passportsó FEI Article 511.
6. All competitors must wear fully completed medical cards for showjumping & cross country Tests.
7. All horses entered in the above classes must be presented for the arrival inspection prior to beginning the event.
8. All relevant information accompanied by the relevant entry fee and must be in the hands of the Secretary, Event-pro, P O Box 7272, Taradale, Napier 4141 by 13 February 2013. All fees listed include GST.
9. All scratchings must be notified immediately. Refunds will be paid for scratchings in accordance with the general conditions of HOY 2013
10. Qualifications ó The qualification period ends on 6 March 2013. Qualification page must be completed for classes 800, 801 & 802. Qualifications of these classes for competitors and horses do not necessarily have to be acquired as a combination.

CODE OF CONDUCT **FOR THE WELFARE OF THE HORSE**

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. *At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.*
2. *Horses and athletes must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.*
3. *Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.*
4. *Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.*
5. *The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.*

"All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. They are therefore strongly advised to take out a third-party insurance providing full coverage for participation in equestrian events at home and abroad and to keep the policy up to date".
