**1. Closing date of entries – Friday, 5 April 2013.**

2. Entries **MUST** have **all horse, rider and owner** details.
3. Entries may be made without fees online, but all fees must be paid by cheque or EFT by 5 April if not online.
4. Postal address: Equestrian SA, Unit 10, 2 Cameron Road, Mount Barker SA 5251
5. Bank details: ANZ Bank, Name: Equestrian South Australia. BSB: 015-650 A/C No: 440041623
6. **Late entries will incur a \$5.00 fee per class.**
7. All current FEI and EA Rules will apply to competitors and horses. All horses must be currently registered and hold a current performance card to compete in graded or official classes – this includes junior horses. All owners and riders must be current members of Equestrian Australia. Performance cards will be requested and prize money withheld until performance card is produced.
8. The Organizing Committee reserves the right at its absolute discretion to alter or amend any part of the program.
9. The Organizing Committee reserves the right to ballot horses if necessary.
10. Protests are to be submitted in writing to the show committee within 10 minutes of the incident and with a fee of \$50.00, to be refunded if protest is upheld.
11. Substitution of a nominated horse may take place only within the nominated Classes and must be notified to the Secretary at least one hour prior to the commencement of the Class.
12. Scratchings: 75% of entry fee will be refunded **only** if Veterinary Certificate or Doctors Certificate is produced within 3 days of the competition.
13. Swabbing will take place. A swabbing fee of \$10.00 per horse must be paid with entries.
14. A Ground fee of \$15.00 per competitor must be paid with entries.
15. Juniors: Competitors may take part in competitions for juniors until the end of the calendar year in which they reach the age of 18.
16. Horses may not compete in competitions for both Junior and Young Rider's Championships.
17. Horses may not compete in competitions for both Young Rider and Senior Rider's.
18. State teams may include one member from another state, if they have insufficient riders present at the event.
19. State teams to be nominated by EA official before 9.00 am Saturday 11 April.
20. Yards (post and rail 2.7m x 2.7m) are available at \$10.00 per horse for the show.
21. **YARDS may be built in specific areas of the grounds only with the permission of the Ground Supervisor. Yards solely relying on Electric tape are not permitted. Yards not permitted on Polo playing field.**
22. No power cords are permitted to cross the driveways.
