How it works

- Set within the event zone, the Waipa Home of Champions Derby course and immediate surrounds, riders and horses will negotiate a showjumping round before heading straight out on to the 2,000m (approx..) XC course. The Showjumping will be a maximum height 2* with a joker to gain extra points, the cross-country will be a maximum 2* with a few 3* options to gain bonus points.
- The competition will be run similar to an accumulator (see scoring below). The winner and place getters will be those with the most points i.e. they have jumped the most (and most difficult) fences clear. In the event of a tie closest to the optimum time will win.
- A fall of either rider or horse at any time in the competition will result in elimination

SHOWJUMPING:

- Each fence cleared is worth 10 points
- There will be 11 single fences (no combinations).
- There will be an optional joker at the 11th fence, you can take the smaller fence for 10 points or go for the joker and get 30 bonus points however, if you take the joker and have a stop or a rail you will lose 10 points!
- If you take a rail or have a stop at a fence you get no points.
- 3 stops in total = elimination
- 1 second over the optimum time = 1 penalty

CROSS-COUNTRY:

- Each fence cleared is worth 10 points, if you have a refusal there will be no points
- There will be a maximum of 6 2* bonus options on the course. Should you jump these clear you will get 30 points, should you have a stop you will lose 10
- 3 stops on the course will result in elimination.
- 1 second over the optimum time = 1 penalty, in the event of a tie closest to the optimum time will win

GENERAL RULES

- All safety requirements and rules are as per ESNZ rules and regulations
- As you will be going directly from the SJ to the XC you do not need to wear jackets for the SJ phase and you will need to SJ in your safety vest.
- The cross-country course will be open for walking at 9am on Sunday morning; the Showjumping will be open from 10am.
- A draw will be done and available on www.mainevents.co.nz but please be prepared to ride ahead of time.



Conditions for the Equissage SJ & XC Challenge

- 1. Riders & horses must have current registration for the duration of the show.
- 2. Times are approximate, any major changes will be communicated to you via Main Events
- 3. Maximum of three horses per rider
- 4. Entry fee includes 1 x wristband per rider
- 5. Extra wristbands available through Main Events \$40
- 6. Night show tickets and tickets to the Dressage Masterclass must be purchased separately at www.equidays.co.nz.
- 7. Equidays reserves the right to exchange cash for product to a maximum of 50%.
- 8. A \$10 non-refundable admin fee per rider applies
- 9. A \$20 ground fee per horse
- 10. Entries close Tuesday 8th October 2019. Please enter at www.main-events.co.nz
- Scratchings refund for all classes and other fees less 25%. Subject to proof of inability to compete. Subject to conditions and refund form being completed within 7 days of the event. Stable and yard fees will be fully refunded up until 8th October 2019.

- 12. All prize money will be paid via internet banking.
- 13. Yards: \$40 for the duration of the event.
- 14. Stables: \$180 for the duration of the event.
- 15. Stables without roof \$100
- 16. All stallions must be stabled when not ridden.
- 17. Camping: Non-powered sites are \$50. Powered sites are \$125 for duration of the event. These prices are per site, not per person.
- **18.** Equidays reserves the right to alter, delete or amend any class as it sees fit.
- **19.** Mystery Creek Events Centre takes no responsibility for injury or loss to competitor, horse or gear.
- 20. No dogs allowed on Mystery Creek Events Centre property at any time.



Equidays Conditions

CONDITIONS

All competitors, exhibitors and participants must comply with the appropriate legislation including the Health and Safety at Work Act 2015. Each competitor, exhibitor and participant must supervise and control their animals at all times and shall be liable for any hazard created, accident, illness or damage caused by the action of themselves at the venue of the event.

EQUIDAYS HEALTH AND SAFETY CONDITIONS

Equidays has a zero harm policy and the safety of all people working at or visiting our venue is of the utmost importance to us. We appreciate your efforts in ensuring your site is safe at all times and that you take all reasonable practicable steps to ensure your own safety and take no action or inaction that causes harm to any other person.

Anyone participating in clinics or competitions associated with ESNZ disciplines, those attending the Pony Club Camp and any treks or pony rides must wear a helmet, however we strongly advise that ALL riders wear a helmet when training, competing and exhibiting to minimise the risk of injury in the event of an accident.

VENUE RULES

- Competitors understand the risks associated with riding horses and acknowledge that your participation is informed and voluntary.
- No dogs or pets are permitted on the Equidays site.
- No digging, drilling or pegs are permitted without approval of the Equidays operations team due to live power, water and data cabling underground.
- Any machinery or equipment must be certified, compliant and in safe working condition.
- The site speed limit is 15km/h.
- All vehicles onsite must drive on the roads only. Damage to sites by vehicle access, parking, manoeuvring or deliveries may result in penalties or remediation by the exhibiting company responsible for the damage.
- All vehicles must have a fire extinguisher
- All incidents, accidents or near misses must be reported to Equidays staff.
- Any fuels, gas or hazardous substances must be stored.

Hazards include but are not limited to:

Horses and Ponies, Contour of Property, Weather Conditions, Equipment and Obstacles, Buildings & Gateways, Water and Water Troughs, Movement of Vehicles

FEI Code of Conduct

- In all equestrian sports the horse must be considered paramount. The well-being of the horse shall be above the demands of breeders, trainers, riders, owners, dealers, organisers, sponsors or officials.
- All handling and veterinary treatment must ensure the health and welfare of the horse.
- The highest standards of nutrition, health, sanitation and safety shall be encouraged and maintained at all times.
- Adequate provision must be made for ventilation, feeding, watering and maintaining a healthy environment during transportation.
- Emphasis should be placed on increasing education in training and equestrian practices and on promoting scientific studies in equine health. In the interests of the horse, the fitness and competence of the rider shall be regarded as essential.
- All riding and training methods must take account of the horse as a living entity and must not include any technique considered by the FEI to be abusive.
- National Federations should establish adequate controls in order that all persons and bodies under their jurisdiction respect the welfare of the horse.
- The national and international Rules and Regulations in equestrian sport regarding the health and welfare of the horse must be adhered to not only during national and international events, but also in training.
- Competition Rules and Regulations shall be continually reviewed to ensure such welfare.

Equidays staff will be monitoring the site at all times. Failure to comply with venue rules may result in you being requested to leave the premises.
