Horse Box Application

- There are a limited number of horseboxes available. Due to the high demand preference is given to order of the following:
Stallions/colt, KMs travelled to the show grounds, mares with foals at foot, young stock
- It is the responsibility of the stallion exhibitors to have a notice stating 'stallion' on the outside of the box. For any stallion that **cannot** be stabled next to any other horses. Please contact the Stable Manager to arrange an alternative solution.
- Should your application for horseboxes be unsuccessful, refund will be made upon written application accompanied by this receipted form, if received by **December 1, 2020**.
- Stables must be cleaned inside and out. Remove ALL dirty, wet straw and sweep aisle. This will be monitored for the duration of the show and failure to comply **will** result in no stable allocation the following year **and** a fine of the full cost of hire.
- Smoking is prohibited in the stable complex. The committee reserves the right to impose a fine of \$1000 on any person found smoking in this area.

Truck and float parking, overnight unattended (non-camping) parking

- Exhibitors camping overnight or for the full show, please complete the Camping Application Form. Reminder to Show Jumping Competitor. Horse Box and Camping Forms must be received at the usual entry **Sunday October 18, 2020**.
- Camping Parking Passes must be displayed in the vehicle windscreen at all times. Unauthorised vehicles left unattended in the stable unloading area or in camping sites without passes will be towed away. Any vehicle found using a previous year's pass will be instantly towed and the owner removed from the grounds and disqualified from the show.
- Any competitor/horse allocated a stable and/or yard for anytime throughout the duration of the show, the horse **MUST NOT** be tied to a horse truck and/or horse float at any time. This will be monitored for the duration of the show and failure to comply **will** result in no stable and/or yard allocation for the following year.
